News & Notes

- Benefits being obtained at this time of the year are still for 2023. This does not mean the benefits will be the same for 2024. If your patient changes insurance companies or insurance plans within the same company, new benefits should be obtained. Remember, even if the company and plan remain the same, the deductibles, out of pocket and copay/coinsurance may change.
- The Medicare Deductible for 2024 will be \$240. This represents a \$14 increase for your patients from 2023.
- \*Effective December 1, 2023-Aetna will no longer pay for Mental Telehealth services conducted via audio only. Each session must include a video component.
- Please remember to notate on your day sheets if a session is via telehealth or inoffice.

> Build an Online Presence:

Website: Create a professional website that includes information about your services, approach, credentials and contact details.

>Search Engine Optimization (SEO):
Optimize your website for search engines to increase its visibility. Use relevant keywords, create quality content and ensure that your site is mobile-friendly.

> Utilize Online Directories: List your practice in online therapy directories such as Psychology Today, Linkedin or your professional association website. Many clients use these platforms to find therapists.

# Important Mental Health Practice Reminders

>If you are supervising a clinician for clinical hours, the clinician must be under the same credentials as you. Also, some insurances require a specific modifier. We need to know if you are supervising in order to submit claims correctly. The dates of service need to be on a sheet with the clinician's name and your name as supervisor. We also need the clinician's information for our records. Questions: Please call us. That is why we are here!

>Beginning in 2024, LPC (Licensed Professional Counselors) and LMFT (Licensed Marriage and Family Therapists) will be able to bill for Medicare clients. If this is something you want to do, we suggest starting the credentialing process now so you'll be good to go in the New Yea

#### Expanding Medicare Beneficiary Access to Behavioral Health Services

The American Psychological Association reports that the November 2023 release of the final rule on the 2024 Medicare fee schedule brings good news for psychologists and aims to increase access to behavioral health services. Psychologists and other mental health providers will see increases in the work values of codes for psychotherapy and behavioral health assessment. The increase in work values will apply to psychotherapy codes 90832, 90834, 90837, 90839, 90840, 90845, 90846, 90847, 90849, and 90853.

CMS did not adopt APA Services' recommendation to increase the work values for the psychological and neuropsychological testing codes, but said it welcomes feedback on the valuation of psychological and neuropsychological testing services and may consider updates in future rulemaking.

CMS will continue to allow providers to use their currently enrolled practice location instead of their home address when providing telehealth services from their home.

#### Charging for No-Shows & Late Cancel Fees

The decision of whether mental health practices should charge for no-shows or cancellations is often influenced by several factors including ethical considerations, the therapeutic relationship and the practical aspects of running a mental health practice. Here are some perspectives on this issue:

- > Charging for no-shows or late cancellations can help offset financial losses for the therapist or mental health practice.
- > Charging for missed appointments can reinforce the importance of commitment to therapy and respect for the therapist's time. It may encourage clients to take their appointments seriously.
- > It may be challenging for practitioners to sustain their practices without some form of compensation for missed appointments. A balance between flexibility and maintaining the financial stability of the practice is necessary.
- > Clearly communicating policies regarding cancellations and no-shows at the beginning of therapy can set expectations and boundaries. This transparency helps clients understand the importance of their commitment to the therapeutic process.

Ultimately, the decision to charge for no-shows or cancellations is a complex one that requires careful consideration of the specific circumstances and the values of the mental health practitioner. Some therapists choose to implement a sliding scale, provide a certain number of "free" missed appointments or work collaboratively with clients to address issues that may lead to cancellations. It's essential to find a balance that respects both the financial needs of the practice and the well-being of the clients.

Take Note: Just one canceled session each week can add up to over \$8,000 a year. To reduce cancellations and missed appointments, many of our clients have established a protocol whereby they email or text a patient reminder concerning their upcoming appointment.


# **New Jersey Providers Take Note**

Legislation (S2716) that would require the state to authorize Licensed Clinical Social Workers (LCSWs) as independent mental health providers under Medicaid/NJ Family Care has been introduced in the State Senate. The National Association of Social Workers-NJ maintains that this legislative action will help increase access to needed mental health care for vulnerable individuals who are enrolled in NJ Family Care. Approval in the State Assembly is also required for the proposal to become law.

\*According to Empower's Financial Happiness report, 60% of Americans maintain that money can buy happiness after achieving a certain net worth. That net worth? Brace yourself-\$1.2 million dollars.
