- \*If you are seeing patients from states other than your location, you need to be licensed in that state. If you want to be in network, you need to be credentialed in the state where you are located (not where the patient is located). The federal COVID-19 PHE declaration ended on May 11, 2023.
- On January 1, 2024, Amerigroup in New Jersey is changing its name to Wellpoint. Important Reminder
- Benefits obtained in December were for 2023. This does not mean the benefits will be the same for 2024. If your patient changes insurance companies or insurance plans within the same company, new benefits should be obtained. Remember, even if the company and plan remain the same, the deductibles, out of pocket and copay/coinsurance may change.

#### **Deductibles Reset for the New Year**

Deductibles contribute to the overall revenue of your mental health practice. By consistently collecting deductibles, the practice reduces the risk of unpaid bills and accounts receivable issues which can negatively impact cash flow.

Mental Health practices often have contracts with insurance providers and payers. Collecting deductibles is a part of fulfilling these contractual obligations and ensuring that the practice remains in compliance with the terms of its agreements.

Communicating your practice requirements clearly to patients is essential for maintaining transparency, managing expectations and ensuring a smooth experience for both the clients and your mental health practice. Clearly explain your deductible payment policy.

#### Medicare Deductible News

The Medicare deductible for 2024 will be \$240. This represents a \$14 increase for your patients from 2023.

#### Employee EAP's Expanding

Per the World Economic Forum, employers see a \$4 ROI for every dollar spent on mental health care in the workplace. Research indicates that mental health practices will see an increase in EAP clients in 2024.

### YES, YOU ARE IN DEMAND

>Employment of relationship therapists, clinical social workers, mental health counselors and psychiatric mental health nurse practitioners is projected to grow 23% from 2020 to 2030, much faster than the average for all occupations overall according to the U.S. Bureau of Labor Statistics.

>Beginning January 1, 2024, Medicare will expand coverage to include marriage and family therapists, as well as mental health counselors. According to Kaiser, this is a huge change for Medicare that has limited mental health coverage to services provided by psychiatrists, psychologists, licensed clinical social workers and psychiatric nurses. MFT's & MHC's makeup more than 40 percent of licensed mental health professionals.

#### Fee Schedule Optimization

> Reviewing your fee schedule yearly as business expenses change and insurance contract rates are adjusted is a sound business practice. Your fees ensure that you remain competitive in the marketplace while simultaneously maintaining the fiscal integrity or your practice. Fee review is applicable to private pay and insurance-based reimbursement clients.

#### Determining Factors When Reviewing Your Fee Schedule

- >Consider your desired annual income, subtracting business expenses and contracted insurance rates. Stay aware of changes in CPT codes and determine whether your fees would be considered industry standards.
- >When setting your fee schedule, it is very important to take into consideration the marketplace you serve. The economics/disposable income of your client base will vary widely when considering geographic location. Also, factor in whether you will be offering a sliding scale to those patients where the need exists. You can budget the dollar amount of expenditure that you want to designate for sliding scale purposes and stay within the guideline.
- >Providers can always request a review of their contracted rates with insurance. Do your homework. Speak to your peers concerning their contractual agreements. Your first inquiry to insurance to obtain a review of reimbursement rates is to contact provider relations. If you have questions concerning fee review, give us a call. We're here to help!

### Coordination of Benefits Request

>Upon the arrival of a new calendar year, many insurance companies request that their policy holders complete a coordination of benefits request. Responding to a COB request helps streamline the claims processing system. Providing accurate and timely information allows insurers to process claims more efficiently, reducing delays and ensuring that claims are handled appropriately. Some insurance policies may have specific requirements regarding COB and failure to comply could affect the patient's eligibility for coverage. In cases where a patient has both a primary and secondary insurance coverage, responding to a COB request helps clarify which insurance plan is responsible for covering the primary costs and which one acts as secondary. \*The American Psychiatric Association reports that focusing on Mental Health is one of the most popular New Year's resolutions for 2024. A Morning Council poll conducted for the APA indicates that the most popular resolutions were related to physical fitness (39%), finances (34%), mental health (28%) and diet (26%). Other resolution topics included spirituality, relationships, traveling, hobbies, organization, career and philanthropy. Nearly half (44%) of young adults aged 18 to 34 years said they planned to make a mental health-related New Year's resolution. Supply and demand becomes an issue for those planning on seeking mental health therapy in the New Year. According to recent data from the Kaiser Family Foundation, 47% of the U.S. population live in a mental health workforce shortage area, with some states requiring up to 700 more practitioners to remove this designation.
