HIPAA and its Application to Minors in Your Practice

Parental Consent and Rights: Generally, parents or guardians must provide consent for treatment of minors (typically under 18), which includes access to medical records. **Confidentiality:** In many states, minors may have the right to confidentiality regarding certain mental health services, especially if they are deemed mature enough to understand their treatment. This includes therapy for issues like substance abuse or reproductive health.

Informed Consent Forms: Ensure that consent forms clearly outline what information will be shared with parents and what will remain confidential.

Variation in Laws: Be aware that state laws may offer different protections and rights regarding minors' confidentiality and parental access. Establishing procedures for reporting any breaches of HIPAA confidentiality is important to avoid fines and in-depth audits. Also, educate minors about their rights regarding confidentiality.

Increasing Revenue at a Mental Health Practice

Expand Services: Offer additional services such as group therapy, workshops or wellness programs that attract new clients and provide more options for existing ones.

Telehealth Options: Implement teletherapy services to reach clients who may prefer virtual appointments, increasing your client base.

If you accept insurance ensure you're in-network with a variety of insurance plans and consider billing for different types of sessions (e.g., assessments, follow-ups).

Client Retention: Focus on building strong relationships with your clients. Regular followups, check-ins and personalized care can encourage clients to continue their therapy.

Marketing and Outreach: Enhance your online presence through a professional website, social media and local SEO strategies. Consider partnerships with local healthcare providers for referrals.

Remember Your Practice is Your Business. Collect Feedback: Regularly solicit feedback from clients to understand their needs and make improvements which can lead to increased satisfaction and referrals.

Diversify Revenue Streams: Consider consulting, coaching or offering training to other professionals which can add to your income.

Workshops and Training: Host workshops on mental health topics to raise awareness and generate additional revenue.

You could consider Sliding Scale Fees: This can help attract clients who might not otherwise be able to afford therapy, potentially increasing your overall client volume.

Collaboration with Other Professionals: Establish relationships with physicians, schools and community organizations for referral opportunities.

Develop Specialized Programs: Consider creating programs for specific populations (e.g., adolescents, veterans) that address their unique needs.

Sure. Cotton Candy tastes great. In fact, dentists highly recommend it. But there is another use for this treat in addition to satiating your taste buds. Cotton candy is indeed an interesting concept when it comes to creating artificial blood vessels! Researchers have been exploring various methods to create scaffolds for tissue engineering, and cotton candy machines can produce fine, fibrous structures that mimic the extracellular matrix. These fibrous structures can provide a supportive environment for cells to grow and develop into functional tissues. The porosity and flexibility of the cotton candy fibers can also allow for blood flow and nutrient exchange, which are crucial for vascular applications. Who Knew?



Warning: If you are offended by the word vibrator you should skip this story. About 82% of American women own a vibrator. Some are now being used in an unorthodox way to help cure migraine headaches. Men and women are applying a vibrator to their foreheads to ease the pressure and pain from migraines. Dr. Adriana LaGier, an Associate Professor of Biology at Iowa's Grand View University, told Wired that her research team investigated vibration and migraine relief after hearing her friends' stories of placing vibrators on their foreheads. "Some of the people using vibration as a therapy for migraine are experiencing huge benefits, it's very exciting to see," Tie-Quang Li, who has studied migraines and vibration at the Karolinska Institute in Sweden, told Wired.

"My mother hated it, so it was hidden away for decades in my house." So says Andrea Lo Rosso about a recently discovered Picasso masterpiece. It's believed that the artwork was painted between 1930 and 1936 and that it's a portrait of Picasso's mistress, French photographer and painter Dora Maar, who was connected to the painter until their breakup in 1945. The painting was eventually put into a cheap frame and hung. "My mother didn't want to keep it, she kept saying it was horrible. This Pablo Picasso is estimated to be worth roughly \$6.6 million. Picasso's distinct signature was discovered in the upper left-hand corner of the portrait. Lo Rosso's mother is said to be "hating" the painting a little less these days.
